One in nine females below the age of 5 die due to postnatal sex selection: report

One in three girls missing globally due to sex selection, both pre- and post-natal, is from India — 46 million out of the total 142 million, according to the UNFPA's State of the World Population 2020 report released on Tuesday.

The figure shows that the number of missing women has more than doubled over the past 50 years, who were at 61 million in 1970.

As per news **"According to estimates averaged over a five year period (2013-17), annually, there were 1.2 million missing female births, at a global level. India had about 4,60,000 girls 'missing' at birth each year."**

2. Certified copies of causes of missing
3. Certified copies of Action taken by the ministry to stop the *missing*.
4. Certified copies of Action taken by the ministry if news media is spreading FAKE NEWS.

Instead replying, WCD forwarded RTI to NCRB, WCD get yearly funding of 25,000 Crore but they do not have data on missing girls.

Then we received A Reply from NCRB

Latest published report "Crime in India" pertains for the year 2018.

Further, your RTI application is being transferred w/s 6(3) of RTI Act, 2005 to **CPIO, Ministry of Women & Child Development** for providing the available information on points directly. In case it does not fall under your jurisdiction it may be further transferred to the Public Authority to which the subject matter is more closely connected, directly, under intimation to the applicant.

- **Further, it is informed that Police is a State subject under the 7th Schedule of the Constitution of India. Hence you are advised to obtain the information directly from the concerned State/UT.**

An appeal, if any, against this reply may be made within 30 days to Shri Vivek Gogia, IG/Joint Director, National Crime Records Bureau, National Highway-8, Mahipalpur, New Delhi-110037 (011-26782547).


