

What is RTI?

Right to Information is an act of the Parliament of India which sets out the rules and procedures regarding citizens' right to information. It replaced the former Freedom of Information Act, 2002.

under RTI Citizens of India are empowered to get required information / Data / Details of Public authority other than some third party and related to national security.

then what is issue with RTI?

In India most of Public services are name sake or blunder to harass or make public to run post to pillar.

here we have a proof of RTI.

If you file RTI with Public authority by speed post or online, most of the time you will get straight answer for what you have asked.

Most of the time Public information officers deny as its third Party information, they do not have asked information or not belong to their department and transferring to other department. and after that there will be no reply from other department.
